Committed to Transparency and Ethics

Anti-corruption standards are a set of rules forming a unified system of prohibitions, restrictions, obligations, and permissions that ensure corruption prevention.

Corruption prevention is an integral part of the activities of Moscow Transport organizations.

We strive to create a safe and reliable environment for our employees and partners.

We direct all our efforts to combat corruption and build all our activities on the basis of honesty, openness, and fairness.



The goals of implementing anti-corruption standards are:

Protecting the Organization

Establishing clear rules and procedures helps protect the organization and its employees from corrupt practices, which can lead to serious legal consequences and reputational damage.

Ensuring Transparency

A policy of openness and awareness allows Moscow Transport organizations' employees and partners to act diligently and impartially.

Promoting Accountability

Implementing measures aimed at responsible conduct by employees at every stage of their activities, and providing tools for reporting all instances of anti-corruption legislation violations, encourages ethical behavior.



Industry-Specific Approach to Corruption Prevention

Corruption prevention work in the Moscow Transport organizations is based on the Industry Program for the Development of the System of Internal Compliance with Anti-Corruption Legislation Requirements and Business Ethics Principles in Moscow Transport Organisations.

Moscow Transport organizations have adopted and implemented internal regulations aimed at corruption prevention. Employees of Moscow Transport organizations must follow these rules and procedures and adhere to high standards of conduct, honesty, and professionalism. An employee can, at any time, refer to internal regulations on the Moscow Transport organizations' website, and on the Unified Transport Portal and the Moscow Transport Corporate Portal.

Training and Legal Awareness

Moscow Transport organizations conduct periodic training and legal awareness sessions for employees on corruption prevention, ethical conduct, and the dissemination of information about current anti-corruption procedures.

Reporting and Investigation Procedures

Moscow Transport organizations have established and operate confidential and secure channels for reporting alleged corruption offenses.

Be Informed

Study the anti-corruption policies of Moscow Transport organizations. Understanding these rules will help you be fully aware and avoid situations that could lead to corrupt offenses and negative consequences.

Report Violations

If you discover suspicious activities, speak out.

Use the Anti-Corruption Hotline for the Department of Transport and Road Infrastructure Development of Moscow to report misconduct by Moscow Transport organizations' managers and employees, and violations of laws, the Code of Ethics and Business Conduct, and internal regulations of Moscow Transport organizations.

All reports received via the Hotline are investigated.

Develop Ethical Behavior

Always strive to be an example of ethical behavior in the work environment and in everyday life. Do not accept any gifts, services, or preferences that could create a conflict of interest situation or violate the anti-corruption policies of Moscow Transport organizations.
